Use double spacing and one inch margins. Separate the answer from the question by beginning the answer on a ...

In general, when instructors say that they want your homework "in APA format" it means: They want the basic structure of an APA paper, which includes these things: 1-inch margins all the way around; Font size: 12 point; Font: Times New Roman; Double-spaced; A title or cover page; A References page (if you used any sources)
