According to the ASX's figures, there were 92 new listings in 2019, down 30% from 2018's total of 132. If you exclude exchange traded funds, debt issues, spin-offs and reverse takeovers - as we did last year - this brings the total down to 63, which is 33.7% lower than the 95 market floats recorded in 2018 and 35% lower than the four-year average of 97.
