The I-129 Supplement for H-1B Data Collection needs to be completed by employers sponsoring a foreign national for an H-1B or H-1B1 visa on Form I-129. This supplementary form collects data about the employer and the foreign national beneficiary in order to determine:

Direct Filing Addresses for Form I-129, Petition for a ...

The I-129 form of the H1B petition is used for permission to the employer to hire foreign workers. This form is handed to the United States Citizenship and Immigration Service. USCIS processes the form and either approves or denies the petition. While it is processing, USCIS sends a receipt number to the employer and employee.

A I-129 Form is used by the U.S. Department of Homeland Security for the petition of a non-immigrant worker visa. The form is required for any worker who does not intend to become a permanent resident to legally enter the United States In this case, we are using the I-129 Form provided by the Department of Homeland Security.

7.5 H-1B Specialty Occupations | USCIS

Regular Processing Form I-129, Petition for a Nonimmigrant Worker, is filed at the California Service Center (CSC), the Vermont Service Center (VSC), the Nebraska Service Center (NSC), or the Texas Service Center (TSC), depending on which nonimmigrant classification and action the petitioner is requesting and where the petitioner is located.

The H-1B employee may present the Form I-94 indicating H-1B nonimmigrant status issued for employment with the previous employer along with his or her foreign passport as a List A document. The new employer should write "AC-21" and the date he or she submitted the Form I-129 petition to USCIS in the margin of Form I-9 next to Section 2.

I-129F: Petition for Fiance Visa - USCIS Guide

An H-1B employee who is changing H-1B employers may begin working for the new employer as soon as the employer files a Form I-129 petition on behalf of the employee. The new petition must not be frivolous and must have been filed prior to the expiration of the individual's period of authorized stay.

Temporary (Nonimmigrant) Workers | USCIS

The I-129 petition is received in at the USCIS service center before the employee's H-1B current status expires; and The employee has been maintaining valid H-1B status since last arriving in the US on an H-1B visa.
