If the letter is from the Department of the Treasury Bureau of the Fiscal Service, these notices are often sent when the IRS takes (offsets) some or part of your tax refund to cover another, non-IRS debt. The Bureau of the Fiscal Service only facilitates the transfers - it won't have information about your IRS account or where the money is being sent.

The letter, dated July 19, 2016, came from the Department of the Treasury, Bureau of the Fiscal Service in Washington. The envelope had a return-address label, a sticker, with an Alabama post-office box. The envelope was stamped with 46 cents postage.

If a federal agency informs Fiscal Service that you owe a delinquent nontax debt, Fiscal Service will send you a letter regarding your debt. That letter will list the federal agency to which you owe a debt and provide information regarding your payment options.

If they claim to be from the Treasury (non-IRS), report it to OIGCounsel@oig.treas.gov. For any report of a fraudulent call, include: The exact date and time that you received the call (s) The phone number of the caller. The geographic location and time zone where you received the call. A description of the communication.

The first listed letter is CP01, which just happens to be what the IRS sends taxpayers who are identity theft victims who have verified their identity to the IRS. This letter lets the taxpayer know that his or her account will be monitored to prevent future fraudulent activity.

The Internal Revenue Service sends you a letter to let you know this will happen and gives you information about the agency you owe. In most cases, you'll receive the notice from the IRS after you file your return, but there is a way to see if you're in the offset system before you file.

What Does a Refund Offset by the Treasury Department Mean ...

You get a check or bill prior to a letter for accounting purposes. The IRS does this to start or stop the clock for penalties and the like. If you get money back you get nothing extra.
