The primary purpose of group counseling notes is to help the client and keep track of his or her progress toward meeting treatment goals 1. These notes are also used to document a client's use of services for payment purposes, generally from insurance companies.

Progress notes can sometimes be viewed as busy work, not central to the client's progress, or only necessary to fulfill administrative requirements. This can be an issue when caseloads are demanding and face-to-face contact seems more important and/or satisfying. However,

Documentation of Substance Use Disorders: Progress Notes

□ Every effort should be made to complete progress notes on the same day as the session. □ Individual and Group Notes must be finalized within 72 hours or 3 business days from the date of the delivery of the service. □ After 72 hours, the clinician must write "late entry" in the "Notes" section of the progress note.

CLINICAL DOCUMENTATION GUIDE

A. All Progress Notes (see Attachment 1 - Sample Progress Note Entry and Attachment 2 - Crisis and Documentation Guidelines) must be completed and finalized in Synthesis within ten (10) days of the contact. A hard copy of the Progress Notes are no longer required to be kept in the client file, as they are now part of

FORMATS USED IN DOCUMENTING CONSUMER PROGRESS S. O. A. P. NOTE S = Subjective or summary statement by the client. Usually, this is a direct quote. The statement chosen should capture the theme of the session. 1. If adding your own explanatory information, place within brackets [] to make it clear that it is not a direct quote.
